- 1. We are looking to wrap up the selection process for a Volunteer Recruiter position very soon.
- 2. Thanks to those 16 corporations that provided information on Gmail and Target Solutions accounts that can be closed out, as requested. Those corporations include: Co. 3, 5, 9, 10, 11, 12, 14, 19/39/43, 25, 27 30, 33/46, 34, 36, 49 and 57. To date we have freed up nearly 200 Gmail accounts for new members.
